- 2. Rope-in-programme: Immediately on admission, you will undergo an orientation programme for approximately one week. It is mandatory on your part to attend the rope-in-programme without any leave or absence.
- 3. You have to observe the dress code of the School as prescribed. During the programme, you must be prepared to buy at your cost text books, workshop tools, drawing equipment and consumables like drawing sheets, print requirements etc. as prescribed by the School. You must meet all the expenses towards boarding & lodging, uniforms, industrial visits, project work etc.
- 4. This offer is only for training & NTTF does not guarantee employment. School of Postgraduate Studies will make all efforts to place you for project work and to get gainful employment. However, no guarantee can be given for placement as it depends on your performance to a very large extent.
- 5. The Management of NTTF reserves the right to terminate your training, if you are declared unfit as per the clauses in the medical fitness format, the blank copy of which is enclosed. You are advised to get yourself medically examined and certified as fit for PG programmes. Submit the certificate on date of start of PG programme.

- You have to maintain an aggregate attendance of 80% minimum, failing which, you will not be allowed to appear for the end semester examinations / assessments. Late comings or unauthorized absence will invite disciplinary action. Students with poor attendance may not be presented for list of campus placements.
- 11. Conditions for withdrawal from programme after admission:
 - a) Student who withdraw from the programme before the commencement of the programme (i.e. before the rope-in programme starts), a processing charge of Rs.5,000 will be charged.  - b) If a student enrolled to a programme withdraws within 30 days from the programme commencement date, a fee of Rs.25,000 plus all actual expenses incurred towards insurance, stationery, etc. will be deducted and the balance will be paid by a crossed cheque within 10 working days on submission of a written request.
 - c) In case the student is relinquishing the seat for whatever reasons after 30 days from the date of programme commencement any time during the period of his / her training, he / she shall forfeit the tuition fee in full along with the miscellaneous fees.
