All assessments will be done on the basis of marks. However, for the purpose of reporting the performance of a candidate, letter grades, each carrying certain number of points, will be awarded as per the range of total marks (out of 100) obtained by the candidate in each subject as detailed below:

- A hybrid of relative and absolute grading system will be followed in assigning grades to students for each course registered.
- A student earning 91-100 marks will be awarded with 'O' grade and 50-60 Marks will be awarded with 'B' grade. The marks in range of 61-90 will be awarded with intermediate grades, which will be fixed based on the mean of marks in each subject.

A student who secures not less than 50% of the total marks (both continuous assessment and end semester examination marks put together) prescribed for the courses with a minimum of 45% marks in the end semester examination for theory courses, theory-cum-practical courses, practical courses (except for the practical courses which are evaluated based on Continuous assessment only) and project work shall be declared to have passed the examination.

The award of letter grades will be decided based on relative grading principle. The relative grading is applicable to ONLY those students who have passed the examination as per the passing requirements enumerated above. For those students who have not passed the examination, Reappearance (U) shall be awarded as shown in the below Table. For those students who have passed the course, the relative grading shall be done. The evolved relative grading method normalizes the results data using the BOX-COX transformation method and computes the grade range for each course separately and awards the grade to each student. For a given course, if the students' strength is greater than 30, the relative grading method shall be adopted. However, if the students' strength is less than or equal to 30 then the fixed grading shall be followed with the grade range as specified below.
